- SUM INSURED:** Up to USD 500,000 per Claimant, subject to and in accordance with the limits and the terms and conditions of the Policy.
- RETENTION:** In respect of each Claimant the sum of all Distributions and Deemed Distributions pertaining to that Claimant, subject to a minimum of USD 20,000 each claimant.
